P Shanmugaraj & Co., Chartered Accountants at the time of taking up the assignment of Statutory Audit of the Company for the FY 2018 to 2023 had provided their consent to the Company that they shall subject themselves to the process of Peer Review and obtain a valid certificate from the Peer Review Board of the Institute of Chartered Accountants of India at the earliest.
